Facts Of Arrest

CURRAN, MARTIN

Dispatch advised of a male at Walmart refusing to put his mask on. Upon arrival, I made contact with Brandon SeEVERS, an employee with Walmart. He stated they have a customer who is refusing to put their mask on. Another employee stated they have asked the male to leave but he ignores them. Brandon advised the customer was currently in the automotive section.

Upon walking to that area, I made contact with Colyn Tusing. I advised Colyn of the complaint and he did not look happy I was there. I explained to Colyn I was there not because he wasn't wearing a mask but because he did not leave. Colyn stated he wasn't told to leave. When I asked him what was going on he stated " you tell me what's going with these people trying to make my decisions." I tried to explain to Colyn that he was on private property but he argued the fact that Walmart was private property. Once I gathered Colyn's information, I asked Brandon if they were trespassing Colyn from the store and I was advised they just wanted Colyn to leave and if he returned, he needed to wear a mask or he would be trespassed at that time. I advised this to Colyn and provided his identification back to him. I advised Colyn to leave the store as directed and he began to walk away. As Colyn walked away, I observed him stick his left hand into his left front pocket and pull the hand out now carrying a pair of brass knuckles. While I was just talking to Colyn he did not have the brass knuckles on.

I stopped Colyn and removed the brass knuckles from his hand and placed his hands behind his back, securing him into handcuffs. He was advised he was under arrest for carrying a concealed weapon. I searched Colyn removing a razor blade knife from his front right pocket which he informed me of. While escorting Colyn from the store he referred to the brass knuckles as being a " deadly weapon. " He also stated " do you really think I'm fucking scared of you. "

I spoke to Judge O'Brien Colyn's charge and he advised to bond Colyn. While at the Erie County Jail, Colyn stated he was suicidal. I transported Colyn to Firelands ER where he was treated and released. I then transported him back to the Erie County Jail where he was incarcerated. Walmart advised they did wish to trespass Colyn from Walmart. Colyn later refused to sign the trespass notice but was advised he was trespassed from the all Walmart's and Sams Club.

The brass knuckles were placed into evidence and the orange knife was put into property for safe keeping.
